Yes some of them made it, Lakeland Village is a perfect example for that point...but we also know, many of them lost their lives within the year after they left. This is not fair!

We do not have the big industries such as Microsoft, Boeing, the shipping yards and docks, the fishing, the professional football and baseball teams, ect, to absorb the loss of jobs over here. We do not have the construction that happens daily on the west side of the state. What we have here are proud, hard working, loyal citizens who want to be remembered by our governor, and representatives who are all over there in Olympia. You asked the question..."What will happen to Medical Lake, Washington should Lakeland Village close?" Well the answer is quite clear. The town will die! But, the impact is far more than just Medical Lake! Lakeland Village employees live not only in Medical Lake, but also the towns of Reardon, Davenport, Nine Mile Falls, TumTum, Cheney, Spokane, Spokane Valley, Sprague, Fish Lake, Newport, and beyond. The Counties that will be affected are not only Spokane County, but Lincoln County, Stevens County, and Pend'Oreille County. The loss of revenue is far reaching throughout all of Eastern Washington! Personal loans will go into default, foreclosures on homes will become the norm rather than the exception. People will be unable to buy groceries, school districts will suffer, stores will suffer, small business owners will lose out on

customers able to use their services. We will depend on welfare and unemployment benefits. The taxes we pay for gas, property, and clothing will suffer. Car sales will all but die, home furnishings, and new furniture will not be bought. Added to the cost is the harm the clients could do to themselves and the community before they are incarcerated.

There are many things to consider, but closing Lakeland Village is not the option! Cut the pay for the university football coaches...they do not have to be the highest paid state employees!
