WHEREAS, Resolution No. 67-25, passed and adopted by the Board of County Commissioners of Spokane County, Washington, on the 10th day of January, 1967, adopted the "Spokane County Traffic Code"; and

WHEREAS, It is now apparent that the best interests of the public would be served by certain revisions to said Traffic Code; and

WHEREAS, A Traffic Engineering Study has been made.

THEREFORE, BE IT RESOLVED By the Board of County Commissioners of Spokane County, Washington, that said Traffic Code be and the same is hereby revised and amended as follows:

SECTION NO. 46.61.5701 – Add the following: “NO PARKING” section:

Located in Section 26, Township 25 North, Range 45 E.W.M.

**SHORE ROAD, along the west side from Tum Tum Drive to Dreamwood Circle,
“No Parking”.**

**KAY ROAD, along both sides from Tum Tum Drive to Dreamwood Circle,
“No Parking on Pavement”.**

**DREAMWOOD CIRCLE, along the inner side of the circle, from mile post 0.045
to 0.075 and from mile post 0.135 to 0.165, “No Parking on Pavement”.**

Located in Section 22, Township 25 North, Range 45 E.W.M.

**COLBY AVENUE, along both sides from Kamiakin Avenue to Liberty Drive,
“No Parking on Pavement”.**

**TAFT AVENUE, along both sides from Kamiakin Avenue to Liberty Drive,
“No Parking on Pavement”.**

**KAMIAKIN AVENUE, along the north side from Liberty Drive to Lilac Lane,
“No Parking on Pavement”.**

**MITCHELL AVENUE, along both sides from Melkapsi Street to Mahko Street,
“No Parking on Pavement”.**

**WRIGHT BOULEVARD, along both sides from seventy feet south of the centerline
of Melkapsi Street Melkapsi Street, “No Parking”.**

**WRIGHT BOULEVARD, along both sides from Clarke Avenue south to twenty feet
from end, “No Parking on Pavement”.**

**WRIGHT FRONTAGE ROAD – along both sides from Wright Boulevard to
Wright Boulevard, “No Parking on Pavement”.**

MAHKO STREET, along both sides from Wright Boulevard to Mitchell Avenue,
"No Parking on Pavement".
CLARKE AVENUE, along both sides from Garry Road to Liberty Drive,
"No Parking on Pavement".
MELKAPSI STREET, along south side from Garry Road to Liberty Drive,
"No Parking on Pavement".

Located in Section 23, Township 25 North, Range 45 E.W.M.

2ND AVENUE, along both sides from Della Road east to Clubhouse,
"No Parking on Pavement".
3RD AVENUE, along both sides from Della Road east to end,
"No Parking on Pavement".
DELLA STREET, along both sides from 2nd Avenue to 3rd Avenue,
"No Parking on Pavement".
HILLVIEW ROAD, along the west side from 1st Avenue to Lakeridge Drive,
"No Parking on Pavement".
LEE STREET, along west side from Overlook Road to 3rd Avenue,
"No Parking on Pavement".
GAGE STREET, along the south side from Lee Street to Neyland Road,
"No Parking on Pavement".
3RD AVENUE, along the north side from Lee Street east to end (700 feet),
"No Parking on Pavement".

The County Engineer is hereby directed and authorized to cause to be posted and maintained signs in accordance with this Resolution and the Washington State Department of Transportation's "Manual for Signing".

The restrictions authorized by this resolution shall take effect upon the placement of signs.
