1 AFFIDAVIT OF GREGORY A. PROFT

- Gregory A. Proft, being first duly sworn upon oath, testifies as follows:
1. I am over the age of 18 years, competent to testify, and I make the below statements based upon my own personal knowledge;
 2. I am currently enlisted in the U.S. Army and stationed at Fort Benning, GA, with duty in Iraq. My military rank is Sergeant Major (SGM).
 3. I have been stationed outside of the United States since OCT 2009.
 4. From August 2001 to August 2002 my primary home or place of abode was in Post Falls, Idaho. Subsequently, I moved on military orders to several locations, but left my family in Post Falls. I sold the home in 2006 and moved my family to the Fort Benning vicinity.
 5. Prior to my deployment overseas I contacted the Idaho Secretary of State's Office to inquire about how I should proceed to maintain my residence in the state of Idaho for voting purposes. I was directed to contact the Kootenai County Clerk's office. I did so
