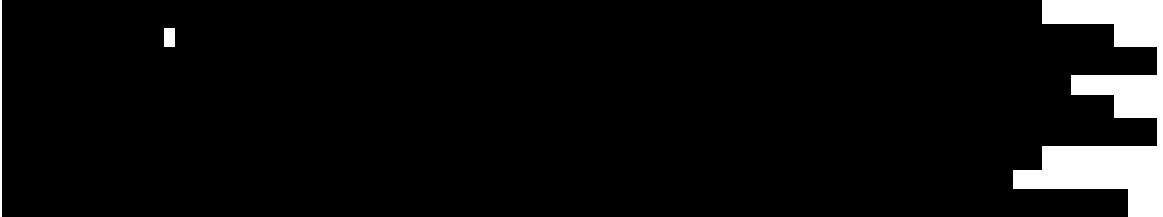

**NARRATIVE:**

On 11/08/10 I spoke with James "Jimmy" Hoffman concerning the burglary of his vehicle.

Jimmy told me his vehicle was parked in the driveway of his home overnight. He last knew his property was in the vehicle at approximately 1200 hours on 11/07/10. He believes his vehicle was unlocked. Today upon arriving home at 1600 hours, his neighbors informed him of several auto burglaries in the neighborhood (see 10C33182). Jimmy checked his truck and discovered his camera missing from the center cubby of the dash of the truck. No other items were missing and there was no damage to the vehicle.



I arrived at the scene and attempted to print the dash area where the camera had been, but found no latent prints. I lifted two poor quality partial prints from the inside edge of the driver's door frame. The passenger door yielded several smears but no prints with ridge definition. The exterior surface of the truck was dotted with moisture from the wet weather. The interior surfaces of the truck cab were mostly textured and no suitable for fingerprinting.

I placed two latent lift cards into evidence.

While I was on scene at this location I was approached by the neighbor, Tracy Worley, who requested I also fingerprint her vehicle. She said she had reported the burglary this morning. See my supplement to that report #10c33183.
