INTRODUCTION

This report was compiled on January 7, 2011 at the request of Captain Childers.

The types of information used to create this report include calls for service, crime reports and field interviews extracted from our Summit database.

Database records were reviewed and compiled based upon both how the record is related to a specific bar or bar activity in general in the downtown Coeur d'Alene area. The following is a table of the establishments and addresses associated with them.

Notably, it is not always possible to obtain information about where a suspect may have been drinking (e.g. too inebriated) or if a particular crime is directly related to a specific establishment. In that context, the **purpose of this report is to provide a general overview of downtown activities in an effort to increase communication between bar establishments and local law enforcement with the final goal of improving public safety.**

Information on BAC (Blood Alcohol Content) as referenced in this report:

State of Idaho BAC DUI Laws:

- **All drivers** with a **BAC .08** or higher (enhanced if **BAC .20** or more)
- **Under 21 years of age** with a **BAC of .02** or higher
- **Commercial Drivers** with a **BAC of .04** or more

Wednesday, December 29, 2010: 2310 hours

N 4th St & E Foster Ave –DUI - #10C38067

Officers arrested a 51 year old male for **DUI (BAC = .179)** after a routine traffic stop. The driver admitted to drinking a couple of beers at the **Iron Horse** earlier that evening.

Friday, December 31, 2010: 0050 hours

317 E Sherman Ave – Alcohol Offense - #10C38163 & #10C38164

Officers cited an intoxicated 20 year old male for **alcohol offenses**. Apparently the offender had thrown a glass at a bartender at the **Beacon** while drinking at the bar.

Friday, December 31, 2010: 0205 hours

216 E Coeur d'Alene Ave – Disorderly - #10C38167

Officers cited a 22 year old male for **urinating in public** in the **Torch Lounge** parking lot.

Friday, December 31, 2010: 2232 hours

216 E Coeur d'Alene Ave – Domestic Dispute - #CD1414643

Officers responded to a **Domestic Dispute** from a female near 2nd St. According to the call, the male was being belligerent with the female earlier and the couple was kicked out of the **Torch Lounge**. After exiting the bar, the male started to run away and tripped and fell on his face. No further information available.

Friday, December 31, 2010: 2311 hours

209 E Sherman Ave – Unconscious - #CD1414651

Officers responded to a call reference a 21 year old female who was intoxicated and passed out in the bathroom of the **Eagle Lodge**. Medical was called. No further information available.

Friday, December 31, 2010: 2340 hours

N 4th St & E Sherman Ave – Battery - #10C38254

Officers arrested a 23 year male for **battery** and cited him for **spitting on the sidewalk** (officer had asked him repeatedly to stop spitting). The intoxicated male had been kicked out of the **Beacon** due to his behavior and level of intoxication. While being escorted out of the bar, the suspect sucker punched a bouncer and was later tackled outside by two bouncers.

Saturday, January 1, 2011: 0049 hours

N 2nd St & E Sherman Ave – Alcohol Offense - #11C00007

Officers cited a 20 year male for being **intoxicated in the roadway** after he was observed stepping onto Sherman Ave and almost being hit by vehicles. The male was highly intoxicated and looking for a cab. He had been drinking at the Baja Bargarita that evening.

Saturday, January 1, 2011: 0108 hours

300 E Sherman Ave – Alcohol Offense - #CD1414688

Officers spoke with a male on Sherman who was highly intoxicated and barely able to talk. The male advised he had been drinking at the **Shore Lounge**. No further information available.

N 3rd St & E Lakeside Ave – Alcohol Offense - #11C00011

Officers cited two females (21 & 24 years) for **open container** after officers noticed them holding beer cans while standing with a group of people on the sidewalk. The females advised the beers were purchased at the **Torch Lounge**.

317 E Sherman Ave – Citizen Assist - #CD1414697

Officers responded to a call reference a female who was intoxicated and crying outside the **Icon**. According to the female she was shoved outside the bar and needed her coat from inside the bar. She advised she had only one or two drinks. No further information available.

115 S 2nd St – Assault - #CD1414700

Officers responded to a call reference a male who had attempted to assault three people on his way outside of the **Coeur d'Alene Resort**. No further information available.

N 4th St & E Sherman Ave – Alcohol Offense - #CD1414703

Officers contacted an intoxicated female who could not stand, speak clearly or locate her identification. She was also unable to remember where she had been drinking. No further information available.

317 E Sherman Ave – Disorderly - #11C00021

Officers cited a 24 year old male for **urinating in public**.

Saturday, January 1, 2011: 0231 hours

320 E Sherman Ave – Disorderly - #CD1414712

Officers responded to a call reference a male who was trying to start fights outside the **Pita Pit**. The male left in a taxi prior to the arrival of law enforcement. No further information available.

Saturday, January 1, 2011: 0233 hours

N 2nd St & E Indiana Ave – DUI - #11C00026

Officers arrested a 36 year old female for **DUI** after a routine traffic stop (driving without her headlights on). The suspect admitted to drinking several vodka and cranberry juice drinks at the **Iron Horse** that evening and a bottle of vodka was found in the vehicle.

317 E Sherman Ave – Fight- #CD1414714

Officers responded to a **fight** call at the **Icon**. The person calling in the fight appeared to be intoxicated and the call was cleared unfounded. No further information available.

317 E Sherman Ave – Alcohol Offense - #11C00030

Officers responded to a call at the **Icon** reference an intoxicated female. Apparently the female's friends had been bringing her drinks. The female could not walk and was drooling as she spoke. No further information available.

2300 N 4th St – DUI - #11C00033

Officers arrested a 39 year old female for **DUI** after noticing her parked and vomiting out of her running vehicle. Upon contact with officers, the female was uncooperative—yelling obscenities and trying to get away from officers. She was also charged with resisting arrest. The suspect had been drinking at the **Beacon** that evening.

Officers responded to the **Iron Horse** reference an intoxicated male who kept coming in the bar and trying to start fights. No further information available.
