Whereas The Federal Department of Education has proclaimed 2006 to 2015 as the "Decade of Sustainable Development Education;" and

Whereas "sustainable development" is United Nations Agenda 21, the globalist agenda to take away our sovereignty, property rights, and constitutional freedoms utilizing the popular but unscientific theory of anthropogenic "global warming;" and

Whereas one of the means that the globalist elite have to ensure continuing support of their programs is, according to Chapter 25 of the *U. N. Sustainable Development Agenda 21*, by indoctrinating the next generation, i.e. "enlisting and empowering children and youth in reaching for sustainability;" and

Whereas Idaho Secretary of Education, Tom Luna announced Idaho's new education reform package at <http://www.sde.idaho.gov/site/studentsComeFirst/> immediately after meeting with globalist Bill Gates and his Plan of "21st Century Classrooms, Great Teachers and Leaders, and Transparent Accountability;" and

Whereas the Gates plan is actually UNESCO's plan for global education and preparation for the global workforce for children, using the Common Core Standards and Gates Foundation plans for data collection and assessments; and

Whereas UNESCO, the United Nations Educational, Scientific and Cultural Organization, is an agency of the United Nations established in 1945 with a stated purpose to use education, science and culture to further the "fundamental freedoms of the UN Charter;" and

Whereas the "fundamental freedoms of the UN Charter" are socialist in nature and include the "U.N. Rights of the Child," a "fundamental freedom" in conflict with the rights and duties of parents guaranteed by the U.S. Constitution to inculcate their own beliefs in their own children; and

Whereas the State of Idaho has accepted federal stimulus dollars to implement the Gates Foundation goals through the Gates-funded Common Core Standards, an over 66-page world core curriculum map for education that is the prerequisite for the Obama administration Race to the Top program; and

Whereas Race to the Top is a program that the State of Texas, and school districts and teachers' unions across the nation have rejected because of program requirements that cost more to implement than federal grants provide, and because these programs lack sufficient details about what will be taught, and because the programs institute a federal takeover of public schools, removing local control over what is being taught; and

Whereas Bill Gates is in agreement with the UNESCO plan for global education and the U.N. Millennium Goals, and has signed onto UNESCO's cooperative agreement in 2004; and

Whereas the Gates Foundation goals include Assessment tracking and Longitudinal Data Collection, along with the intent to mandate and facilitate vaccination mediated population control using cell phones to register each newborn into a vaccine database by which vaccination will be tracked; and

Whereas the UN Millennium goals, part of the Common Core Standards, are not about proven educational skills in reading, writing and arithmetic, but rather training workers for co-ordination and control of every aspect of life and work for all citizens; and

Whereas plan funding would provide laptop computers to high-school freshmen with no consideration of parents' concerns, and replace nearly 1100 Idaho education jobs with "technology;" and

Whereas the plan would eliminate job security and reward teachers primarily on whose students do well on federal achievement tests, the jobs of broader-based teachers will be at risk; and

Whereas Mr. Luna argues that this "reform" plan is necessary because of decreasing state revenues, despite the plan offering no details on how the state would fund the programs; and

Whereas, this Plan includes "broadband connectivity to every public school," i.e. Wi-Fi, which has not been proven to be safe, and, in fact, parents in Montana are being required to sign waivers that they will not sue the schools if their children suffer neurological or genetic damage from exposure to school Wi-Fi; and

Whereas, since school boards have the right to accept money directly from the federal government for implementing federal or U.N. programs and parents will have no say in school board decisions to teach U.N. agendas; and

Whereas teachers without contracts can be fired for any or no reason, teachers could lose their jobs for refusing to teach programs that are against their belief systems - including transgender education; and

Whereas Idaho Secretary of Education Tom Luna is trading Idaho state sovereignty, teachers' jobs, parental rights, privacy rights, and the control of the minds and futures of our children for Gates Foundation grants;

Whereas if the State of Idaho is to remain sovereign and our children are to remain free and independent global indoctrination must be eliminated from the curriculum in the State of Idaho and education must return to true academics; and

Therefore Be It Resolved, that the Bonner County Republican Central Committee asks that the State of Idaho refuse all federal Department of Education funds including "Stimulus" funding, "Race to the Top" funding, "Common Core Standards" funding, funding for "Assessment tracking and Longitudinal Data Collection," and "Innovational technology; and sever all ties to that Federal agency; and

Be It Further Resolved, that the BCRCC requests the Idaho House of Representatives investigate the Department of Education's ties to the grant money coming from the Gates Foundation; and

Be It Further Resolved, that the BCRCC requests that the Idaho Department of Education return education to true local control; and

Be It Further Resolved, that the BCRCC respectfully requests that SB1184 be returned to Committee to evaluate current pilot programs currently in effect for the 2012 school year.
