INTRODUCTION

This report was compiled on July 12, 2011 at the request of Captain Childers.

The types of information used to create this report include calls for service, crime reports and field interviews extracted from our Summit database.

Database records were reviewed and compiled based upon both how the record is related to a specific bar or bar activity in general in the downtown Coeur d'Alene area. The following is a table of the establishments and addresses associated with them.

Notably, it is not always possible to obtain information about where a suspect may have been drinking (e.g. too inebriated) or if a particular crime is directly related to a specific establishment. In that context, the **purpose of this report is to provide a general overview of downtown activities in an effort to increase communication between bar establishments and local law enforcement with the final goal of improving public safety.**

Information on BAC (Blood Alcohol Content) as referenced in this report:

State of Idaho BAC DUI Laws:

- **All drivers** with a **BAC .08** or higher (enhanced if **BAC .20** or more)
- **Under 21 years of age** with a **BAC of .02** or higher
- **Commercial Drivers** with a **BAC of .04** or more

Note: This week's report does not include alcohol offenses that did not appear to be related to Coeur d'Alene downtown bars (e.g. Tubbs Hill open container).

Officers responded to a physical **fight** call. Subjects were warned. No further information available.

Friday, July 1, 2011: 2337hours

317 E Sherman Ave – Unwanted Person - #CD1464968

Officers responded to an **unwanted person** call at the **Icon**. No further information available.

Officers responded to a **disorderly** call. Subjects were warned. No further information available.

Officers responded to a **fight** call at the **Icon** and upon arrival found a 20 year old male (from California) pointing and screaming at another male. A female was trying to hold the screaming male back. A large crowd was forming and when the officers attempted to pull the screaming male aside, he pulled away and yelled “get the fuck off me.” As they moved away from the crowd, the male continued to yell at and tried to push the officer. He was handcuffed and arrested for obstructing. After he was arrested, the male continued to fight with officers forcing two of them to pull him into the patrol car. In the course of this incident, officers recovered a fake ID the male was using to gain entry into the bars.

Officers were stationed for fireworks break up when they initiated a DUI investigation on a driving impaired motorcycle that had driven around the road closed signs. While this was occurring, two women began fighting and hitting a car in the nearby parking lot. Two officers responded to this incident and two resort security officers assisted with directing traffic. One of the remaining officers then initiated a second DUI investigation and arrested a 21 year old Washington male for **DUI** after noticing the male talking very loudly and slurring his words while driving his vehicle. During this traffic stop, officers noticed a half full Derailer drink container in the back seat of the vehicle and when asked, the occupants told officers this drink was purchased from the beer garden in front of the **Coeur d'Alene Resort**. Because this was during the fireworks break up operation, ISP responded to finish this report.

He did not remember leaving the bars; however, he did remember being in the hot tub (he thought he was at his friend's house). The male was arrested for **unlawful entry** and **obstructing an officer**.
