

RESOLUTION NO. 11-10

A RESOLUTION OF THE BOARD OF DIRECTORS OF CENTRAL VALLEY SCHOOL DISTRICT NO. 356, SPOKANE COUNTY, WASHINGTON, REQUESTING THAT A SPECIAL ELECTION BE CALLED IN ORDER TO SUBMIT TO THE QUALIFIED ELECTORS OF THE DISTRICT THE PROPOSITION OF WHETHER EXCESS PROPERTY TAXES SHOULD BE LEVIED TO PAY A PORTION OF THE DISTRICT'S SCHOOL PROGRAMS AND OPERATION EXPENSES; PROVIDING FOR THE SUBMISSION OF THE PROPOSITION OF AUTHORIZING SUCH LEVIES TO THE QUALIFIED ELECTORS AT A SPECIAL ELECTION TO BE HELD ON TUESDAY, FEBRUARY 14, 2012; PROVIDING FOR THE NOTICE OF SUCH ELECTION; AND PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO

BE IT RESOLVED BY THE BOARD OF DIRECTORS OF CENTRAL VALLEY SCHOOL DISTRICT NO. 356, SPOKANE COUNTY, WASHINGTON, as follows:

WHEREAS, Central Valley School District No. 356, Spokane County, Washington (the "District"), is a first-class school district duly organized and existing under and by virtue of the Constitution and the laws of the state of Washington (the "State") now in effect;

WHEREAS, pursuant to Revised Code of Washington ("RCW") 84.52.053, the District may authorize up to a four-year excess levy for maintenance and operation support, when authorized to do so by a simple majority of the qualified electors of the District;

WHEREAS, the Board of Directors of the District (the "Board") hereby determines that the money in and to be paid into the District's General Fund during the 2012-2013, 2013-2014, 2014-2015 and 2015-2016 school years will be insufficient to enable the District to meet all of its school programs and operation expenses;

WHEREAS, to provide properly for such school programs and operation needs, the Board hereby deems it necessary and advisable that: (1) an excess tax of approximately \$4.19 per \$1,000 of assessed valuation, to provide an aggregate amount of \$27,100,000, be levied in 2012 as part of the taxes to be collected in 2013; (2) an excess tax of approximately \$4.19 per \$1,000 of assessed valuation, to provide an aggregate amount of \$27,100,000, be levied in 2013 as part of the taxes to be collected in 2014; and (3) an excess tax of approximately \$4.19 per \$1,000 of assessed valuation, to provide an aggregate amount of \$27,100,000, be levied in 2014 as part of the taxes to be collected in 2015, with such excess taxes to be deposited into the District's General Fund and used to pay a portion of the District's school programs and operation expenses;

WHEREAS, the Constitution and the laws of the State require that the proposition of whether or not such excess taxes may be levied must be submitted to the qualified electors of the District for their approval or rejection; and

WHEREAS, the Board deems it necessary and advisable to place the proposition for such excess tax levies before the qualified electors of the District at an election to be held within the District on February 14, 2012;

NOW, THEREFORE, IT IS HEREBY FOUND, DETERMINED AND ORDERED, as follows:

Section 1. The Board hereby determines that the best interest of the students and other residents of the District require the District to place before the qualified electors of the District, for their approval or rejection, the issue of whether excess property taxes should be levied within the District to pay a portion of the District's school programs and operation expenses.

Section 2. To provide money to pay a portion of the District's school programs and operation expenses as described in Section 3 below, the following taxes for the District's General Fund shall be levied upon all taxable property within the District in excess of the maximum annual tax levy permitted by law without voter approval.

Section 3. If the proposition specified in Section 6 below is approved by the qualified electors of the District as required by the Constitution and the laws of the State, the District shall be authorized to use such levy proceeds during the 2012-2013, 2013-2014, 2014-2015 and 2015-2016 school years to pay such part of the District's school programs and operation expenses as may be authorized or allowed by law for the use of such levies.

Section 4. Upon approval of such proposition, the District may issue warrants, bonds or other lawful indebtedness against the District's General Fund for such school programs and operation expenses.

Section 5. The Spokane County Auditor, as ex officio Supervisor of Elections for the District, is hereby requested to call and conduct a special election to be held within the District on Tuesday, February 14, 2012.

Section 6. Pursuant to RCW 29A.36.071, as amended, the Spokane County Prosecuting Attorney is directed to prepare the concise description of the proposition for the ballot title substantially in the following form:

Section 7. The special election will be conducted by mail ballot. The procedures and forms to conduct the special election by mail ballot shall be prescribed by the Spokane County Auditor in accordance with chapter 29A.48 RCW and chapter 434-250 WAC.

Section 8. The Spokane County Auditor shall prepare the notice of special election which shall be published at least once, which publication shall take place not more than ten days nor less than three days prior to the date of such election. Such publication shall be in a newspaper of general circulation within the District.



Section 10. All resolutions in conflict with this Resolution are hereby repealed in their entirety.


Section 11. This Resolution shall take effect immediately upon adoption.



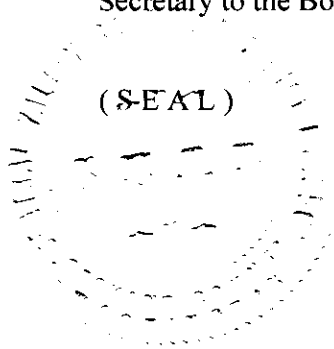

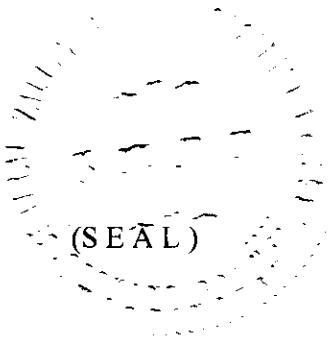

RESOLUTION NO. 11-14

A RESOLUTION OF THE BOARD OF DIRECTORS OF CENTRAL VALLEY SCHOOL DISTRICT NO. 356, SPOKANE COUNTY, WASHINGTON, PROVIDING FOR THE PROCEDURES, CONDUCT AND NOTICE OF AN ELECTION TO BE HELD ON FEBRUARY 14, 2012; AND PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO

BE IT RESOLVED BY THE BOARD OF DIRECTORS OF CENTRAL VALLEY SCHOOL DISTRICT NO. 356, SPOKANE COUNTY, WASHINGTON, as follows:

WHEREAS, Central Valley School District No. 356, Spokane County, Washington (the "District"), is a first-class school district duly organized and existing under and by virtue of the Constitution and the laws of the state of Washington (the "State") now in effect;

WHEREAS, the Board of Directors of the District (the "Board") adopted Resolution No. 11-10 (the "Election Resolution") to place the proposition described in the Election Resolution for excess tax levies before the qualified electors of the District at an election to be held within the District on February 14, 2012;

WHEREAS, 38 out of the 39 counties in the State conduct all elections by mail ballot;

WHEREAS, the State legislature has determined that there be uniformity in the State with respect to the conduct of elections and the manner of voting;

WHEREAS, the voting period for elections begins 18 days before and ends at 8:00 p.m. on the day of such election;

WHEREAS, in order to implement such uniformity of conducting elections and voting, the State legislature adopted Engrossed Substitute Senate Bill 5124;

WHEREAS, the Spokane County Auditor has requested express direction to conduct the February 14, 2012 election pursuant to Substitute Engrossed Senate Bill 5124; and

WHEREAS, the District desires to provide such express direction;

NOW, THEREFORE, IT IS HEREBY FOUND, DETERMINED AND ORDERED, as follows:

Section 1. The Spokane County Auditor is hereby authorized and directed to conduct the February 14, 2012 election pursuant to Engrossed Substitute Bill 5124.

Section 2. Such election will be conducted by mail ballot. The procedures and forms to conduct such election by mail ballot shall be prescribed by the Spokane County Auditor in accordance with chapter 29A.40 RCW and chapter 434-250 WAC.

Section 3. The Spokane County Auditor shall prepare the notice of such election which shall be published at least once, which publication shall take place not more than fifteen days nor less than five days prior to the deadline for mail-in registration. Such publication shall be in a newspaper of general circulation within the District and in accordance with RCW 29A.52.355.

Section 4. Repealer

All prior resolutions of this Board or any parts thereof in conflict with this Resolution are hereby repealed to the extent of such conflict.

Section 5: Ratifier


All of the acts of the Board and officers and employees of the District which are in conformity with the intent and purposes of this Resolution shall be and are hereby ratified, confirmed and approved.

Section 6: Effective Date

This Resolution shall take effect immediately upon its adoption.
