The maximum an individual may contribute to Newt 2012 is \$2,500 for the primary election and an additional \$2,500 for the general election. Couples may contribute up to \$5,000 for each election; joint contributions require the signature of both spouses. Federal multicandidate PACs may contribute up to \$5,000 for each election. By submitting your contribution, you agree that the first \$2,500 of a contribution will be designated for the 2012 election, and any additional amount, up to \$2,500 will be designated for the 2012 general election. Contributions from corporations, foreign nationals, and federal government contractors are prohibited. Contributions must be made from personal funds and may not be reimbursed by any other person. Federal law requires us to use our best efforts to obtain and report the name, mailing address, occupation, and name of employer for each individual whose contributions aggregate in excess of \$200 in an election cycle
