INTRODUCTION

This report was compiled on July 5, 2012 at the request of Captain Childers.

The types of information used to create this report include calls for service, crime reports and field interviews extracted from our Summit database.

Database records were reviewed and compiled based upon both how the record is related to a specific bar or bar activity in general in the downtown Coeur d'Alene area. The following is a table of the establishments and addresses associated with them.

Notably, it is not always possible to obtain information about where a suspect may have been drinking (e.g. too inebriated) or if a particular crime is directly related to a specific establishment. In that context, the purpose of this report is to provide a general overview of downtown activities in an effort to increase communication between bar establishments and local law enforcement with the final goal of improving public safety.

The male told officers the two are ex girlfriend/boyfriend but had been drinking at downtown bars that evening. 1920 E Sherman Ave - #CD1573874 – Fight – Officers responded to a fight call in the alley behind the **Hogfish** involving a male who had pulled a knife on another male. **Warning.**

416 W Mullan Rd - #CD1575628 – Assault Knife – A male was threatening another male while in the City Park lifting his shirt and showing a knife. The suspect male (20 yrs) was contacted and checked for weapons (none found). He told officers the other male had looked at him "funny" so he confronted him, but he did not display any weapons during the encounter. However, the male also reported to the officer that someone had stolen his "flag" out of his pocket and that he was currently trying to get into the "Rollin 60's" gang. The male was uncooperative with officers. **No Report.**

Fights / Batteries / Resisting/ Disorderly:

Friday, June 1, 2012: 2149 hours

501 E Sherman Ave - #12C16014 – Battery – Officers were dispatched to a battery at **Scratch** involving a 40 year old male who had just punched a server (30 year old male) and left, heading toward the **Iron Horse.** The suspect male was very intoxicated and had been escorted out of the restaurant after yelling and harassing other customers. Approximately 15 minutes after he left, the suspect male returned, and the **Scratch** server attempted to block his entry. The male forced his way in, pushed the server and punched the server in the face with a closed fist. The two began to wrestle and a customer broke up the fight. The suspect male then took off down Sherman Ave. The next day, the suspect called into the bar and claimed two employees of **Scratch** had jumped him the previous evening. From this call, officers were able to locate the suspect's telephone number to identify him, and the case was forwarded to detectives for further follow up.

Saturday, June 9, 2012; 0156 hours

N 15th St & E Sherman Ave - #12C16819 – Battery – Officers responded to a battery call involving a taxi driver and a very intoxicated 22 year old male. Apparently the taxi driver had driven the male to this location, but when the taxi driver asked for the taxi fare, the male swung at the taxi driver hitting him in the shoulder and knocking him to the ground. Conversation with the intoxicated male was limited – several versions of what happened that changed minute by minute from the taxi driver attacking him to being beat up before getting in the taxi to the taxi driver not letting him get into the vehicle. The male was very intoxicated, slurring his speech. He told officers he had been drinking at a friend's place before heading to downtown bars (Beacon, Moose Lounge). The male was cited for battery.

Sunday, June 10, 2012: 0046 hours

301 E Sherman Ave - #12C16916 – Disorderly – Officers arrested a 22 year old male for urinating in public after observing the male urinating while talking on his cell phone. When officers approached the male, they noted he was very intoxicated, would not acknowledge the officers or provide identification. After asking and even pleading with the male to speak with them, they arrested him.

Friday, June 15, 2012: 2215 hours

400 Block E Lakeside Ave - #12C17655 – Battery – Officers noticed a male (47 years) urinating behind a car. The male appeared to be intoxicated (red eyes, slurred speech) and became agitated with asked for his identification stating "you want to make a big deal out of this fine." When officers attempted to cite the male for "disorderly," the male told the officer to take him to jail. The officer placed the male in custody and took him to jail.

Friday, June 15, 2012: 2231 hours

204 S 3rd St- #12C17659 – Resisting – Officers were contacted by security at the Iron Horse regarding a male who they observed throwing a beer bottle at another person and then ran down Sherman Ave. When officers approached the suspect, a 33 year old male, he was incoherent and yelling at several females sitting on the corner. The officers followed the male who was walking and yelling obscenities and destroying property (snow marker on hydrant) as he made his way. When officers attempted to stop the male, he turned away from them. Once stopped, the male was asked to sit on the ground, and he responded by becoming aggressive with officers, lunging at them. The male was handcuffed. When the male then tried to head butt the officer in the leg, officers struggled with him on the ground while he yelled, I'm resisting. I am resisting. I admit that." While transporting the male to a patrol vehicle, the male began swinging and kicking at officers until his legs were restrained as well. The male was arrested for malicious injury to property and obstructing.

Saturday, June 16, 2012: 0142 hours

N 2nd St & E Coeur d'Alene Ave - #12C17693 – Battery – Officers responded to a fight call involving a large group of people. Upon arrival a 26 year old female approached officers and stated she had been punched in the face. She told officers she and her male friend had been in the **Rendezvous** when a male had approached her and would not leave her alone. She went on to say that when she and her male friend left the bar, the suspect male (30 years) followed them, grabbed her in her genitals area, and she turned and hit him in the face. The male then swung and hit her in the face. Her male friend then stepped in between them, and the suspect male attacked him as well. The suspect was located in front of the **Rendezvous** yelling at security. When asked to step aside with the officer, the suspect turned, looked at the officer and took off running into the bar. The male had blood on his face and shirt consistent with being in a fight. The male was located in the bar and escorted outside. According to the male, he is a MMA fighter and the female's male friend challenged him to a fight, and when he didn't want to fight, the girl called him a "pussy," and started punching him in the face. He went on to say that when the female was punching him, his nose began to bleed and he threw blood in her face, that her friend must have thought he hit her and then the male friend attacked him. Notably, the female did not have blood on her face. The suspect male, who was very intoxicated (staggering, slurred speech) was cited for fighting in public and battery. He later telephoned the police department stating he wanted to press charges as well.

Saturday, June 16, 2012: 2334 hours

407 E Sherman Ave - #12C17824 – Disorderly – Officers cited a 30 year old male for urinating in public in the **Iron Horse** parking lot. The male was obviously intoxicated and had trouble maintaining his balance, walking and talking.

Saturday, June 16, 2012: 2337 hours

407 E Sherman Ave - #12C17825 – Disorderly – Officers cited a 42 year old male for urinating in public. The male told officers the lines to the rest room were too long in the **Moose Lounge**, and he decided to go outside. The male was nearby another business that had no waiting lines for the restroom.

Friday, June 22, 2012: 2236 hours

204 S 3rd St - #12C18602 – Disorderly – Officers cited a 25 year old male for urinating in public in the **3rd St Parking Lot.** The male was nearby several businesses with facilities as well as portable potties (Iron Man).

Saturday, June 23, 2012: 0046 hours

200 E Sherman Ave - #12C18615 – Battery – Officers responded to a battery call at the Splash bar where the victim had been assaulted by two unknown males and was now lying unconscious on the ground. According to bar security, the victim, a 25 year old male, had been outside the bar "acting cocky" and picked a fight with another male. The other male and his friend responded by "body tackling" the victim and then kicking and punching him while he was on the ground. The victim was kicked approximately three times in the head, and then the males took off running. Medical was called for the victim, and when conscious he refused medical treatment. The victim said "nothing" happened ,and he did not want to pursue charges. When asked for his identification, the victim grabbed his crotch and stated, "here you go," started making a motion like he was masturbating, and told the officer, "oh yeah, in your face." The victim repeatedly refused to give the officer his ID until one of the females nearby grabbed his wallet from his back pocket. The suspects were never located.

200 Block E Sherman Ave - #12C19565 – Disorderly – Officers cited a 22 year old male for urinating in public. The intoxicated male told officers the line was too long at the **Baja Bargarita**.
