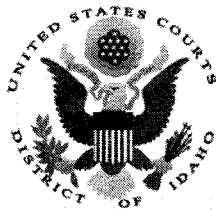
Kootenai County on the entire amount of the judgment prior to dividing the installments between Plaintiffs Kootenai County and ICRMP.
