

If the Defendant has previously been convicted on two separate occasions of a "most serious offense" as defined by RCW 9.94A.030(24), in this state, in federal court, or elsewhere, the mandatory penalty for this offense is life imprisonment without the possibility of parole pursuant to RCW 9.94A.030(32)(a) and 9.94A.120(4) or 9.94A.570.

Description of the Incident: While on routine patrol in the city of Colville, in Stevens County. I WENT INTO TALKING COFFEE TO GET A CUP OF COFFEE. THERE WERE 3 MALES IN THE BUSINESS AND 1 FEMALE THAT WAS ASLEEP ON THE COUCH. IT STRUCK ME AS ODD BUT PAID NO ATTENTION TO IT. I THEN LEFT AND I WAS DISPATCHED TO A DOA AT 222 1/2 W. 2ND.

I WAS ADVISED THAT A GARBAGE MAN WAS PICKING UP GARBAGE AT THAT ADDRESS AND A MALE CAME TO HIM AND ASKED THAT HE CALL 911 AS HE THOUGHT HIS BROTHER WAS DEAD. I ARRIVED SHORTLY AFTER.

I KNOCKED ON THE DOOR OF THE HOUSE THAT I WAS VERY FAMILIAR WITH FROM PAST ASSAULTS AND ALCOHOL ABUSE. ROBERT BARR CAME TO THE DOOR AND LET ME IN. I IMMEDIATELY SAW DAVID BARR IN A SITTING POSITION ON THE COUCH. HE LOOKED TO HAVE BEEN BADLY ASSAULTED. I CHECKED FOR HIS PULSE BUT COULD NOT FIND ANY. HE WAS COLD TO TOUCH AND OBVIOUSLY DECEASED. BARR SAID THAT A FEMALE THAT HE SAID WAS A COUSIN DID IT TO DAVID. HE SAID HE HAD NO IDEA WHY. I THEN CALLED SGT. KENDALL TO EXPLAIN MY FINDINGS. HE AND DET. MAXEY ARRIVED AND I EXPLAINED THE SCENARIO.

I TRANSPORTED ROBERT BARR TO THE POLICE DEPARTMENT FOR AN INTERVIEW. ALONG WITH DET. MICHAEL GEORGE FROM THE STEVENS COUNTY SHERIFFS OFFICE WE TALKED WITH HE SAID THAT DAVID AND DEENA BAILEY WERE SITTING AROUND THE HOUSE. HE SAID THEY WERE DRINKING BEER AND WHISKEY AND GETTING DRUNK. EVENTUALLY AN ARGUMENT STARTED. HE SAID THEY WERE ARGUING OVER THINGS THAT WERE "STUPID." HE SAID HE GOT TIRED OF LISTENING TO IT AND WENT TO BED. HE SAID HE WENT TO HIS ROOM AND TURNED THE TV ON TO IGNORE IT. HE SAID THAT HE WAS SURE THAT DEENA KILLED HIM. I ASKED HIM IF HE SAW DEENA HIT DAVID. HE SAID THAT, "SHE WAS WALLOPING THE SHIT OUT OF HIM." I ASKED WHAT SHE USED TO HIT DAVID WITH. HE SAID THAT SHE USED HER HANDS. HE SAID THAT SHE CLAIMS TO BE, "BIG INTO MARTIAL ARTS." I ASKED IF THERE WAS ANY WEAPONS AT ALL USED AND HE SAID HE DIDN'T KNOW.

HE SAID THAT HE HEARD DAVID MAKE A CALL FOR SOMEONE TO COME PICK HIM UP. HE SAID HE COULD NOT REMEMBER THE NAME OF THE MALE THAT LIVES IN NORTHPORT THAT USUALLY TRANSPORTS DAVID AROUND. HE SAID AFTER HE WENT TO HIS ROOM HE HEARD A CAR ARRIVE AND WAS CERTAIN THAT THE MALE WAS THERE TO PICK DAVID UP. HE SAID HE HEARD THE DOOR OPEN AND SOMEONE LEAVE. HE SAID HE FIGURED THAT IT WAS DEENA LEAVING. WE LATER FOUND OUT THAT NO VEHICLES STOPPED AT BARRS RESIDENCE AND NO ONE GOT PICKED UP.

DET. GEORGE CONDUCTED A DIGITAL RECORDED INTERVIEW. IT WILL BE TRANSCRIBED AND ATTACHED TO THIS REPORT. DURING OUR CONVERSATION I ASKED IF HE HAD ANY IDEA WHERE DEENA WOULD HAVE WENT. HE SAID HE HAD NO IDEA. I ASKED IF HE KNEW WHAT SHE WAS WEARING AND HE SAID HE DID NOT KNOW. I THEN REMEMBERED THE FEMALE THAT WAS ON THE COUCH AT TALKIN COFFEE.

I LEFT THE ROOM AND TOLD DET. MAXEY ABOUT THE FEMALE. HE CALLED TALKING COFFEE AND THE FEMALE WAS STILL THERE. I SENT OFFICER WALLS TO THE BUSINESS TO IDENTIFY THE FEMALE. HE WENT THERE AND SHE IDENTIFIED HERSELF AS DEENA BAILEY. I ADVISED OFFICER WALLS TO DETAIN HER AND BRING HER TO THE OFFICE.

AS SHE WAS ESCORTED IN THE FRONT DOOR OF THE OFFICE, I ESCORTED MR. BARR OUT THE BACK DOOR. I ASKED HIM IF THERE WAS A FRIEND WHO HE COULD HANG OUT WITH AS WE DID NOT WANT HIM BACK AT HIS RESIDENCE UNTIL THE SCENE WAS CLEARED. COULD GO TO MARY ANN THORNTONS RESIDENCE ON W 9TH. DET. MAXEY CHASED AFTER ME AND ASKED IF I COULD SHOW BAILEYS ID TO MR. BARR FOR IDENTIFICATION. HE IMMEDIATELY SAID, "YEAH, THAT'S DEENA." I THEN HELPED MR. BARR INTO MY PATROL CAR. I TRANSPORTED HIM TO MS. THORNTONS RESIDENCE AT 651 W. 9TH. I DROPPED HIM OFF AT 0953. I ASKED MS. THORNTON TO KEEP HIM AT HER HOUSE UNTIL THE SCENE WAS PROCESSED. SHE SAID THAT SHE WOULD.

I THEN ASKED SGT KENDALL WHERE HE WANTED ME AND HE SAID HE WANTED ME AT THE SCENE TO SECURE IT. ONCE AT THE SCENE THE PLAN CHANGES AND I WAS DIRECTED TO THE POLICE DEPARTMENT TO INTERVIEW DEENA BAILEY.

I ARRIVED AT THE OFFICE AND MET WITH DET. GEORGE. WE ENTERED THE CONFERENCE ROOM. DEENA BAILEY WAS SITTING WITH HER HEAD ON THE TABLE. IT APPEARED THAT SHE WAS SLEEPING. SHE WOKE UP AND AND WE INTRODUCED OURSELVES. I TOLD HER THAT THE REASON WE WERE ALL THERE IS THAT WE WERE INVESTIGATING AN ASSAULT THAT HAPPENED AT DAVID BARRS RESIDENCE. I TOLD HER THAT BEFORE WE WENT ANY FURTHER, I HAD TO READ HER CONSTITUTIONAL RIGHTS TO HER. I READ THEM VERBATIM FROM THE RIGHTS FORM WHICH SHE SAID THAT SHE UNDERSTOOD AND WOULD TALK TO US. SHE SIGNED THE FORM WITH THE SIGNATURE OF DEENA L. BAILEY.

WE WENT OVER HOW SHE ENDED UP IN COLVILLE. SHE SAID THAT DAVID MADE CONTACT AND TOLD HER THAT HE MISSED HIS SISTER AND WANTED HER TO COME UP TO VISIT. SHE GOT A RIDE FROM AN ACQUAINTANCE FROM PLUMMER, IDAHO. SHE ARRIVED A FEW DAYS AGO.

SHE SAID THAT ON THE FIRST NIGHT (010713) SHE SLEPT AT A HOTEL ROOM WITH DAVID AND CHARLOTTE THOMPSON. DAVID AND CHARLOTTE GOT INTO AN ARGUMENT AND HE LEFT. HE WENT TO ROBERTS HOUSE. ON 010813, SHE SAID SHE SLEPT ON ROBERTS COUCH.

SHE CONTINUED BY SAYING THAT THE EVENING OF 010913 THAT ROBERT, DAVID AND HERSELF WERE AT HIS HOUSE DRINKING. SHE SAID A MALE WITH LONG BLACK STRAIGHT HAIR STOPPED BY AND SHOVELED THE WALKING AREA. SHE ADVISED THAT EVERYONE WAS DRINKING BEER AND WHISKEY. SHE SAID HE VISITED FOR A WHILE. SHE WENT ON BY SAYING THAT ROBERT AND DAVID STARTED SEXUALLY HARASSING HER. THE OTHER UNKNOWN MALE DID NOT SAY MUCH. SHE SAID THAT SHE EVENTUALLY GOT MAD AND LEFT WITH A PLAN OF HITCH HIKING TO SPOKANE. WE ASKED IF SHE ASSAULTED DAVID AND SHE SAID THAT SHE DIDN'T. SHE SAID SHE LEFT THE HOUSE AND WALKED THE STREETS. SHE SAID THAT SHE TALKED TO 2 DIFFERENT OFFICERS AND THEY WOULD NOT HELP HER. SHE SAID THAT SHE WAS COLD AND HUNGRY. WE DECIDED TO TAKE A BREAK. AN OFFICER WENT TO MCDONALDS AND GOT HER SOMETHING TO EAT.

HER MEAL ARRIVED AND WHILE SHE ATE, WE TALKED SOME MORE. DET. GILMORE WAS ASKING HER SOME QUESTIONS AND SHE WAS SAYING THAT DAVID AND ROBERT WERE SEXUALLY HARASSING HER. SHE WENT ON TO ACCUSE US OF PROTECTING ROBERT AND DAVID. WE ASSURED HER THAT WE WERE NOT PROTECTING ANY ONE. SHE STARTED TRYING TO OFFEND DET. GILMORE AND HE LEFT THE ROOM. SHE WENT ON BY SAYING THAT ALL SHE WANTED TO DO WAS GET A RIDE TO SPOKANE AND GO TAKE CARE OF HER VAN THAT HAD EXPIRED TABS. SHE DID NOT SEEM TO CARE WHAT OUR INVESTIGATION WAS CONCERNING. SHE WAS SHOWING SINGS OF BEING UNCOOPERATIVE AND BEING HOSTILE. SHE KEPT SAYING THAT ALL SHE WANTED TO DO WAS GET OUT OF TOWN AND GO FIX HER VAN WHICH WAS IN PLUMMER, IDAHO. SHE SAID IT WAS AT HER FRIENDS APARTMENT. HIS NAME IS THEODORE GAZE.

I EXPLAINED TO BAILEY THAT OUR JOB WAS TO PUT HUGE PUZZLES TOGETHER. THIS CASE

WAS A PUZZLE AND SHE WAS CARRYING A LOT OF THE PIECES THAT WE NEEDED TO COMPLETE THE PUZZLE. I TOLD HER THAT SHOWING ANY HOSTILITY TOWARDS US AS LAW ENFORCEMENT DOES NOT HELP HER OR ANY ONE ELSE. ALL THAT WE WERE TRYING TO DO WAS FINISH WITH THIS CASE SO WE COULD ALL MOVE ON FROM IT.

I ASKED HER WHO LIVED AT HER MAILING ADDRESS IN SPOKANE. SHE SAID IT WAS A FRIEND.

I WAS CALLED OUT OF THE CONFERENCE ROOM. I LEFT AND WAS TOLD THAT JOSHUA CONNER WAS HERE AT THE OFFICE AND WAS CONCERNED FOR ROBERT AND DAVID. APPARENTLY HE WAS THERE LAST EVENING AND WAS SHOVELING SNOW FOR ROBERT.

WE BROUGHT CONNER INTO THE OFFICE AND TOOK HIM IN A SIDE ROOM. HE SAID THAT HE STOPPED BY ROBERTS AND SAW THE CRIME SCENE TAPE AND FIGURED HE WOULD COME UP HERE TO SEE IF THERE WAS SOMETHING GOING ON THAT HE SHOULD KNOW ABOUT. HE SAID HE KNEW THAT AN UNKNOWN FEMALE WAS HITTING DAVID BUT WANTED TO FIND OUT IF HE WE TOLD HIM THAT WE REALLY DID APPRECIATE HIM COMING IN AS HE WAS THE UNKNOWN MALE THAT WAS SHOVELING THE SIDEWALK AT BARRS HOUSE. WE TOLD HIM THAT DAVID WAS NOT OK, AND WAS IN FACT DECEASED. CONNER BECAME UPSET BECAUSE DAVID AND HIM WERE FRIENDS. WE ASKED HIM FROM THE BEGINNING OF HIM ARRIVING AT BARRS HOUSE WHAT HAPPENED.

HE SAID THAT HE STOPPED BY ROBERTS HOUSE TO SEE IF HE COULD SELL SOME BEADWORK AND A FEATHER. ROBERT COULD NOT BUY THEM SO JOSH ASKED IF HE COULD SHOVEL SNOW TO MAKE SOME MONEY. ROBERT AGREED TO PAY HIM FOR SHOVELLING SNOW. CONNER SHOVELED SNOW AND THEN WENT IN THE HOUSE TO VISIT. HE HAD A DRINK WITH THEM AND DAVID AND THE FEMALE STARTED ARGUING. HE SAID HE HAD NO IDEA WHO THE FEMALE WAS AND HAD NEVER MET HER BEFORE. HE SAID THE ARGUMENT GOT PRETTY BAD AND HE STARTED TO INTERVENE AND ROBERT TOLD HIM NOT TO AS IT WAS FAMILY ISSUES. CONNER AGREED WITH IT AND SAID HE WAS GOING TO LEAVE. HE DID SAY THAT THE FEMALE WAS, "SMACKING THE SHIT OUT OF DAVID." HE SAID THAT HE SAW HER KICK DAVID IN THE LEGS AND FEET. HE SAID SHE SWUNG AT DAVID WITH A BAG. THE BAG HAD TOOLS IN IT. HE WAS NOT SURE WHERE OR IF DAVID WAS STRUCK WITH THE BAG.

THE FEMALE SAID THAT SHE WAS GOING TO LEAVE. HE SAID THAT HE LEFT AS WELL AND HE WALKED WITH HER TO THE AREA OF 2ND AND MAIN. HE SAID THAT SHE WAS A "BITCH" AND HE LEFT HER THERE.

HE LATER WENT BACK TO BARRS HOUSE. WHEN HE ENTERED THE HOUSE DAVID WAS BLEEDING FROM THE MOUTH AND HAD A SWOLLEN EYE THAT WAS BRUISING. HE SAID THAT DAVID WAS LAYING ON THE COUCH WITH IS HEAD ON A PILLOW AND HE COULD SEE MORE BLOOD UNDER HIS HEAD. HE SAID THAT HE ASKED DAVID IF HE WAS OK AND THAT HE SHOULD GO UP TO THE HOSPITAL TO GET CHECKED OUT. DAVID REFUSED AND SAID HE WOULD BE OK AND COULD STILL BEAT HIM AT CHESS. CONNER LEFT AGAIN. HE SAID THAT IN HIND SIGHT THAT HE WISHED HE WOULD HAVE TAKEN DAVID TO THE HOSPITAL. HE SAID THAT BOTH ROBERT AND DAVID WERE HIGHLY INTOXICATED. HE SAID THAT THEY ARE ALWAYS DRUNK.

DET. GEORGE AND I CONDUCTED A DIGITALLY RECORDED INTERVIEW WITH CONNER AND IT WILL BE TRANSCRIBED AND ATTACHED TO THIS REPORT.

WHEN WE WERE FINISHED TALKING WITH CONNER, I WENT BACK TO THE CONFERENCE ROOM WHERE BAILEY WAS AT ALONG WITH DET. GILMORE. WE GAVE HER THE OPPORTUNITY TO GIVE US ANY MORE INFORMATION THAT WOULD HELP US IN OUR INVESTIGATION. SHE SAID SHE TOLD US EVERYTHING. WE INFORMED HER THAT 2 SEPARATE WITNESSES SAW HER HITTING DAVID AND KICKING HIM AND THEN HITTING HIM WITH THE TOOL BAG. SHE WOULD

INTERRUPT US SAYING THAT SHE HATES THIS TOWN AND WANTED TO LEAVE. WE TOLD HER THAT SHE WAS NOT FREE TO LEAVE. SHE SAID THAT ALL WE HAD TO DO WAS ASK DAVID WHAT HAPPENED.

WE INFORMED HER THAT WE COULD NOT ASK DAVID AS HE WAS DEAD. SHE SHOWED SIGNS OF BEING SURPRISED. I TOLD HER THAT WE WERE NEVER THERE INVESTIGATING AN ASSAULT AND WE WERE THERE INVESTIGATING A HOMICIDE. I LET HER KNOW THAT WE DID NOT USE THIS MANY OFFICERS AND DETECTIVES TO INVESTIGATE AN ASSAULT.

SHE ADMITTED TO HITTING DAVID WITH THE TOOL BAG BUT SHE WOULD ONLY SAY THAT HE PROBABLY PUKED HIMSELF TO DEATH. SHE SAID THAT HE WAS PUKING UP WHAT APPEARED TO BE BLOOD THAT NIGHT AND IT GROSSED HER OUT AND WAS GOING TO MAKE HER VOMIT AS IT SMELLED BAD. SHE SAID THAT IT WAS SELF DEFENSE BECAUSE DAVID AND ROBERT WERE SEXUALLY HARASSING HER. SHE SHOWED NO SIGN OF BEING UPSET OVER HER HALF BROTHERS DEATH.

I LEFT THE ROOM AND TALKED TO MY CHIEF AND OTHER DETECTIVES. IT WAS DECIDED THEN TO ARREST BAILEY FOR MURDER 2ND DEGREE. I TOLD THE CHIEF I NEEDED PAPER BAGS FOR HER CLOTHING AS IT NEEDED TO BE PLACED IN EVIDENCE. HER CLOTHING HAD VISIBLE BLOOD ON THEM. AN OUTER JACKET THAT SHE WAS WEARING WAS AN ARMY CLASS "A" JACKET. THERE WAS AS SUBSTANTIAL AMOUNT OF BLOOD ON IT. HER COAT AND JACKET WAS SEIZED FROM HER AND PLACED IN PAPER BAGS.

I TOLD BAILEY THAT SHE WAS UNDER ARREST FOR MURDER 2ND DEGREE. THE TIME WAS 1320. SHE SAID THAT SHE DIDN'T KNOW WHY BECAUSE, "HE WAS STILL ALIVE WHEN I LEFT."

SHE WAS TRANSPORTED TO THE STEVENS COUNTY JAIL FOR BOOKING. THE REST OF HER CLOTHING WAS SEIZED AND PLACED IN PAPER BAGS FOR PRESERVATION. THEY WERE PLACED INTO EVIDENCE WITH FORM #CPD2062.
