NARRATIVE
 On 06-21-2014 at about 2154 hours, [REDACTED] called in concerned about what she overheard at the Rancho Viejo Mexican Restaurant, and said she took pictures of some of the people involved. Due to priority calls I wasn't able to contact her until about 2300 hours.

When I did contact [REDACTED], she said she was in the restaurant with a friend and observed several males together talking and they were talking about the Bundy Ranch, the Militia, Snipers, Special Forces, Churches, Oath Keepers, and she said she heard the names of Stewart Rhodes and Ryan Payne mentioned. She also indicated they were talking about a thermal night vision monocular and were passing it around for everyone to look at.

[REDACTED] didn't hear all of the conversations but said she heard enough that it concerned her and she thought maybe these guys were planning some type of attack.

[REDACTED] said she looked up Stewart Rhodes and Ryan Payne on google and found they were associated with the Militia and Oath Keepers. She said she recognized Stewart as the one doing most of the talking.

[REDACTED] sent me 2 photos of the guys to my email which I will forward to the JTTF, along with a copy of this FI.
