



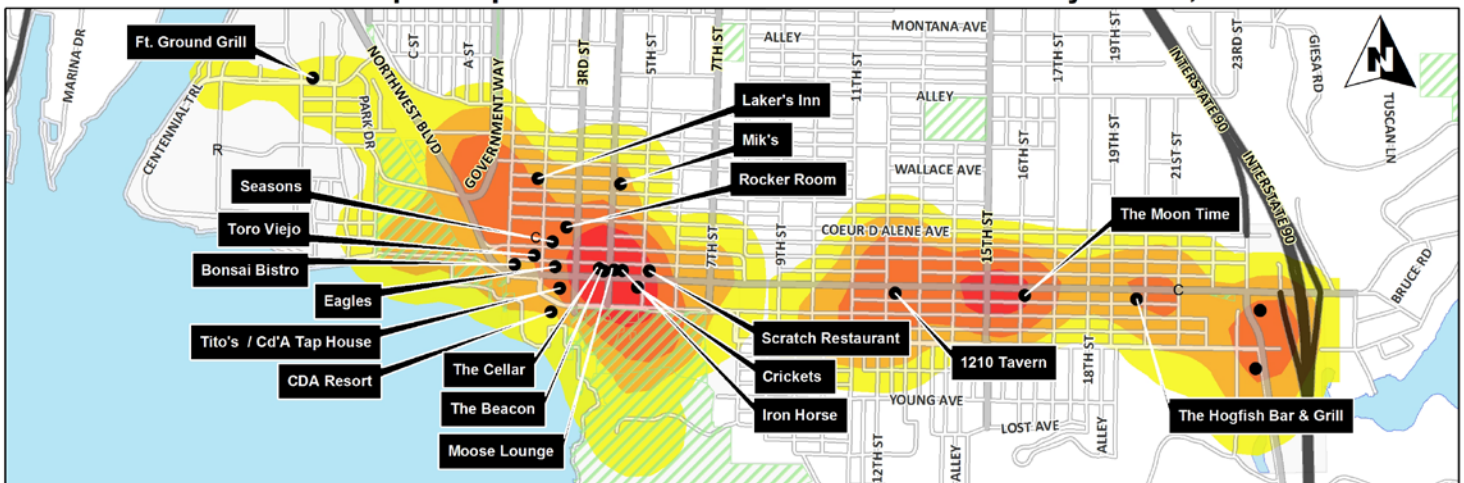
# Coeur d'Alene Police – Crime Analysis Downtown Activity / Crime Report: July 22- 28, 2015

The types of information used to create this report include calls for service, crime reports and field interviews. **These records were reviewed and compiled based upon both how the record is related to a specific bar or problem activity in the downtown Coeur d'Alene area.** Notably, it is not always possible to obtain information about where a suspect may have been drinking (e.g. too inebriated) or if a particular crime is directly related to a specific establishment. In fact, the below **“hot spot” maps reflect ALL calls or crimes reports** – not just those directly related to downtown bars. In that context, **the purpose of this report is to provide a general overview of downtown activities in an effort to increase communication between bar establishments, businesses, residents and local law enforcement with the goal of improving public safety.**

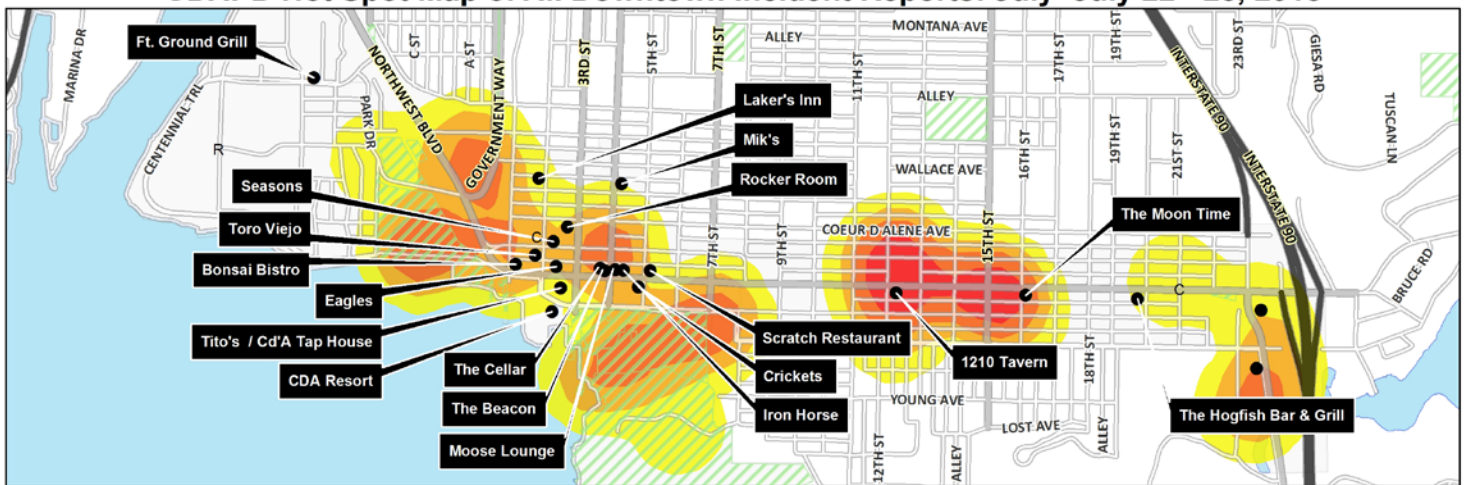
## Information on BAC (Blood Alcohol Content) as referenced in this report:

**State of Idaho BAC DUI Laws:** All drivers with a BAC .08 or higher (enhanced if BAC .20 or more) or Under 21 years of age with a BAC of .02 or higher or Commercial Drivers with a BAC of .04 or more.
